Conditions of membership:

In order to have an account facility extended to you, you agree that should you wish to place your flying training on account you understand that you will be charged the \$7 extra per flying hour account maintenance facility fee. To keep this service available, your invoices must be paid by their due date (14 days after EOM). Your account cannot exceed \$1000 at any given time and must have a ZERO balance before ANY flight tests can be undertaken. The Bunbury Aero Club reserves all rights to exercise the assistance of a debt recovery agency if an account remains unpaid.

It is necessary that you know the policy of the Bunbury Aero Club in regards to cancellation of Navigational Training Flights for the PPL and Pilot Certificate. It is essential that you notify the Bunbury Aero Club 48 hours prior to your scheduled flight if you are unable to attend your scheduled lesson. Any Navigational Training Flights cancelled by the student within 48 hours of scheduled departure will incur a Navigation Cancellation fee of \$100. This policy is to ensure that our instructors and club aircraft are available to students and members at all times. Navigational Training Flights cancelled due to inclement weather do not incur a Navigation Cancellation Fee.

In consideration of my being elected a member of the club and granted the facilities of membership, I hereby agree that before flying in any club aircraft or taking part in any of the activities of the club, I will make myself acquainted with the Club Bylaws, Rules and Regulations.

And I further agree to observe to indemnify the Bunbury Aero Club Inc., their agents and servants from and against all liabilities for any damage or injury sustained by me in the course of, in connection with any flight in any aircraft owned or controlled by the club, or any damage or injury sustained by any other person other than a member of the club, carried in any aircraft hired by me from the club, in the course of or in connection with any flight in such aircraft.
